EMERGENCY CLOSURE POLICY

St. Paul's Church Nursery believes the safety of all children in our care is paramount and their welfare is our first priority:

The Emergency Closure Procedure will only be implemented in extreme circumstances, including:

- Power failure
- Fire damage
- Flooding
- Snow
- Ice
- Heatwave
- High levels of sickness among our staff or children
- No heating or water in the building
- A Bereavement
- An emergency services incident
- Pandemics
- Government Regulatory Closure
- Local Authority Regulatory Closure

The list of contacts of the children is kept securely in the setting. The parents/carers will be made aware through email/telephone or in person depending on the time of the emergency occurring and the nature of the incident.

The Nursery administrator will contact parents when in the setting, or the named practitioners will be given the responsibility of phoning, texting the parents/carers, or via Famly, to let them know the situation.

The Head/Deputy will be in charge of keeping the children safe, during Nursery hours until collection has taken place, along with another qualified teacher (ratio dependent).

The parents/carers are made aware that they will be contacted by email regarding reopening, unless this form of communication is not possible. The parent will be made aware of refunds and compensation or extra days (in line with Surrey County Council) to be added in lieu.

Staff are also aware of the policy and procedure and their obligations.

We follow the guidelines of Reporting Injuries, Diseases and Dangerous Occurrences Regulations (RIDDOR) for the reporting of accidents and incidents. www.hpa.org.uk

The emergency closure will be recorded in the Incident Book and kept securely, and will be reviewed termly to identify potential or actual hazards. Ofsted will be notified as will Surrey Early Years and Childcare Service/The Early Years Free Entitlement Team. This will be done by the Bursar or Head/Deputy.
